I have offered an interdisciplinary honors seminar in the spring of 2017 and 2019 (UH 3500) on early U.S. documents, which culminated in a trip to Virginia and Washington, D.C.

MOCK TRIAL COACH:

From 1989 to 2013, I worked with colleagues to coach mock trial teams at Middle Tennessee State University and, since 1990, to host an annual invitational tournament, which is one of the nation's largest. I helped teach a class each fall and generally accompanied students on about six to eight tournaments a year. MTSU teams have qualified for participation in the National Championship Tournament (which hosts 64 teams) for 18 of 21 years and placed in the top ten for more than half of these years. I believe this is as good a record as any public university in the nation. Numerous MTSU mock trial students have qualified as All-American Attorneys or Witnesses, and most have gone to law school.

As a Chair, I further supported the development of a Mediation Team, which has been active since 2000. This team has also consistently placed in national competition, and has twice been national champion. One of our mock trial students won a \$10,000 scholarship at the National Diversity Mock Trial Tournament in Chicago in 2007. Another won a \$3,000 scholarship in 2008. I have included further information in an appendix.
