## Total Number of Disciplinary Cases: 629 (Summer 2007: 63; Fall 2007: 307; Spring 2008: 259)

A **disciplinary case** is defined as a student or organization that has been charged with a disciplinary offense. The case number does not reflect the total number of disciplinary referrals made to the office. One student may have multiple cases.

The following data presents a synopsis of the breakdown by gender and classification of the students who had discipline cases with the Office of Judicial Affairs and Mediation Services during the specified time period.

\*\*\*The statistics contained in this report represent disciplinary cases adjudicated by the Office of Judicial Affairs and Mediation Services for the time period indicated. Formal charges may have also been filed with the MTSU police department and/or the Department of Housing and Residential Life. It is possible that a single violation may appear in reports from all three departments. Disciplinary matters that were adjudicated solely by the Department of Housing and Residential Life are not reflected in these statistics.

## Noteworthy Observations

Compared to the previous academic year, 2006-2007:

- The office saw an increase in total number of cases by 214 total cases.
- The percentage of cases resulting in a finding of not responsible rose from 7.6% to 21% of total findings.
- The incidence of "Conduct Dangerous to Self/Others" violation types rose from 20 to 126 total violations.
- The incidence of "Public Intoxication" violation types rose from 98 to 212 total violations.
- The incidence of "Alcoholic Beverages" violation types rose from 94 to 162 total violations.
- The incidence of "Drugs" violation types rose from 63 to 109 total violations.

- The incidence of "Drug Parapharnalia" violation types rose from 46 to 71 total violations.
- The incidence of "Abuse of Computing Resources" violation types rose from 2 to 71 total violations.
- The incidence of "Academic Misconduct" decreased slightly from 126 to 110 total violations.
- Violations involving alcohol and/or drugs comprised approximately 42% of all violations.

## Educational Outreach

The Office of Judicial Affairs and Mediation Services conducted a total of 70 educational presentations for the time period specified. The office did educational presentations in 34 U1010 classes and 20 Alcohol Edu classes. Other audiences included athletics, the greek community, faculty, and special student populations.

Noteworthy Observations:

- Ms. Amanda Samsel coordinated the Alcohol Edu program which will be expanded for the 2008-2009 academic year. The class is offered to first and second time alcohol offenders to educate them about alcohol use and abuse.
- Ms. Samsel recruited graduate students to teach the Alcohol Edu classes. Ms. Samsel has continued the recruitment efforts to include undergraduate students as peer educators for the 2008-2009 academic year.
- Ms. Sosh-Lightsy and Ms. Samsel presented at the 2008 ACPA conference.
- Ms. Sosh-Lightsy and Ms. Samsel presented to the U1010 faculty regarding discipline and classroom management. Dr. Gene Fitch presented to the PE faculty on the same subject.
- Ms. Sosh-Lightsy and Ms. Samsel presented to the 2007-2008 Exchange students. Plans are to expand this presentation to the international student population for the 2008-2009 academic year.
