Dear Chapter Members,

I hope you've had a wonderful beginning to the new semester, and I trust you have found the time to talk to the new hires in your department about the many pleasures and delights of being a dues-paying member of the AAUP. If you haven't, you have been a very bad boy/girl!

In marked contrast to previous summers, the chapter has been quite busy this summer. Indeed, it feels as though we've already put in a semester's worth of work. The following is a brief summary of the highlights.

- Pippa Holloway (President-Elect) and Alfred Lutz (President) attended New Faculty Orientation on August 18. We introduced our association to about thirty-five of our new colleagues. We had a good time, and I hope we convinced a few of them to become members.
- 2. The chapter helped a non-tenure-track faculty member who was let go by his department to regain his position. Everybody involved in the negotiations—faculty as well as administration—proved a delight to work with.
- 3. I assume you received an electronic copy of the *Study of Faculty Salaries at MTSU* (May 2015). Several of the authors are members of our chapter, and the chapter contributed substantially to the printing costs of the report. Working with the co-authors of the report was

a delightful experience.

- 4. The chapter is helping faculty members who are facing a case of administrative overreach in the person of their chair as well as a faculty members exposed to a bullying senior colleague. In response to the former, the chapter has produced a document outlining the basic principles of academic freedom and shared governance, and we trust that that reminder will suffice to resolve this problem.
- 5. Earlier this month, I met with Ms. Nneka Norman-Gordon, the state of Tennessee's Higher Education Resource Officer (HERO). (Don't get me started on the acronym.) The two documents accompanying this issue will give you a sense of our HERO's purpose and intended role. I assume--just my guess--that the legislature decided to create this office as a result of the rather embarrassing events at TSU a few years ago, but, as I said, that's just my guess.

In our conversation, I talked at some length about the principles of shared governance and academic freedom, about the role tenure plays in their manifestation, and I followed up our conversation by sending HERO a copy of the AAUP Redbook. Ms. Norman-Gordon will be a guest at the October meeting of the TBR Faculty Sub-Council, on which I serve for one more year.

All in all, a productive summer and, clearly, evidence for the continued importance of our chapter.
