Brigadier General Daniel began his military career 29 May 1959 when he was commissioned, Second Lieutenant, Infantry (USAR) (Senior ROTC), serving in the United States Army Reserve until 5 July 1959.

On 2 April 1962 he began serving as Platoon Leader of the 1st Ambulance Platoon, Co A (Ambulance), 230th Medical Battalion. He continued in this assignment until 31 March 1963 when he was appointed as Medical Administrative Assistant of Company D, 230th Medical Battalion. He continued to serve in Company D, 230th Medical Battalion until 1 February 1968.

On 1 February 1968 BG Daniel was transferred to Headquarters and Company A, 230th Medical Battalion, serving as Company Executive Officer, 1 February 1968 through 31 August 1969; Adjutant S-1, 1 September 1969 through 31 January 1972 and Psychologist, 1 February 1972 through 25 November 1973.

BG Daniel was transferred to the Marksmanship Training Unit 26 November 1973, serving as Information Officer, 26 November 1973 through 31 August 1975. He was promoted to Major effective 26 November 1973.

On 1 September 1975 BG Daniel was transferred to Headquarters and Headquarters Detachment, TNARNG, assuming the responsibilities of HQS Commandant until 14 February 1980. While assigned to this organization he served as Public Information Officer, 15 February 1980 through 30 April 1981; Senior Administrative Officer, 1 May 1981 through 14 February 1983; Selective Service officer, 15 February 1983 through 6 April 1987 and Secretary of the General's Staff, 7 April 1987 through 1 September 1987. He was promoted to Lieutenant Colonel effective 15 February 1980 and Colonel effective 4 April 1987.

BG Daniel was transferred 2 September 1987 to Commander, Detachment 1, State Area Command, Troop Command through 1 April 1992.

BG Daniel was transferred to Deputy STARC Commander, State Area Command 2 April 1992 and attached to Detachment 1, State Area Command, Troop Command, 3 April 1992. He was promoted to Brigadier General on 3 April 1992. Detachment 1, State Area Command, Troop Command was redesignated as 80th Troop Command, 1 July 1994.
