This Revision forms a part of the Contract Documents and modifies the original Documents dated November 8, 2024 as outlined here in addition to being shown on the drawings.

#### CHANGES TO THE OVERALL SCOPE:

The scope of work for Addendum 2 includes answers to prebid questions, one (1) revised specification section, and three (3) revised sheets.

#### **Prebid Questions:**

- 1. On page E101 fixture types '4L' is listed on (3) fixtures just south of the food court. No fixture type '4L' is listed on fixture schedule. Please clarify if these are correct type if so can you provide information on fixtures. ICT Response These should be type '44L'.
- 2. Between drawings E101C and E101D room labeled 'Emergency Elec. 120C, no fixtures are show in this room. Also no note description is shown if no work is to be done in this room. Also room labeled "Receiving 104D" only shows (1) fixture type "3" for the room, can we clarify total count of lights in the room? ICT Response A type '3' has been added to revised E101C for both rooms 120C and 104D. Reference revised drawing.
- **3.** On page E102C, fixtures in room "269" no type is given. Please clarify? ICT Response This is a Type '1'.
- 4. If any new fixtures require 0-10v dimming is the contractor responsible for providing new dimming cable/ dimming controls and programming? ICT Response The only rooms with dimming control is Ballroom 250 and Video Theater 208 in the Student Union, the Auditorium in the Keathley University Center, and the Tennessee Room 250 in James Union Building. All others areas are on/off only. Contractor is responsible for integrating dimming and programming for the rooms with dimming existing only.
- 5. Page E101B, fixture type "22" has multiple different lengths show, fixture type also has multiple lengths with part emergency and part none emergency. This page shows 8' fixtures as a single fixture, 8' fixtures shown as (2) 4' fixtures and 8' fixtures shown as (2) 4' fixtures with ½ emergency lighting and ½ non-emergency lighting. Are all fixtures type "22" lamp sizes the full length of fixtures or are they in 4' sections? For the emergency is a single lamp to be used for emergency lighting or will sections of the entire fixture be emergency? ICT Response The type '22's are pendants the lengths indicated on the plans with the 3 lamp 4' T8 lamps per 4' section of pendant (i.e. an 8' length fixture would have 6 lamps). Emergency is shown for 4' sections of some of the longer pendants. Contractor to provide emergency integral lamp for 1 of the lamps in the 4' section indicated.

- **6.** Is contractor responsible for programming of DMX modules needed for type "46A" fixtures? ICT Response Yes, contractor is responsible for the programming of DMX modules for the type '46A'.
- 7. Can we clarify which fixtures are currently dimmed on this project and what type of dimmer is used so we can provided compatible products or anticipate changing/ replacing with compatible dimmers? ICT Response Contractor shall provide compatible dimmer for new lighting specified/contractor provided in Video Theater 208. Ballroom in Student Union (ETC), Auditorium in KUC (Lightronics), and Tennesee Room in JUB (Lightronics) should utilize dimmers/DMX modules compatible with existing systems.






