This project will replace pleated and vericel filters in AHU on campus (Walker Library). This project will save energy by lowering the pressure drop across the AHU filter bank and slowing the units motor down. The motor will use less kwh saving energy. This project also includes cleaning coils for this building.

If this project is approved it will reduce Co₂ emissions, reduce the volume of filters being disposed to Murfreesboro land field, and seal off filter banks (no escape of air around filter banks).Cleaning coils will save an additional \$2,400 per year.
