**Summary/Abstract:** Items in this collection of papers pertain to farmer and businessman Floyd Hayes, his family, and their business ventures in Smithville, Dekalb County, Tennessee. Many items in the papers, such as receipts and record books, pertain to the operation of the Hayes farm during the 1960s. There is one unidentified photograph and some personal papers, but most of the documents relate to the Hayes family business.

**Biographical Note:** Mr. Hayes was a farmer and businessman in Dekalb County and worked with several establishments in Smithville, TN. He and his family operated a farm during the 1960s.

**Scope and Content:** The materials in the papers are primarily farm and bank receipts. Also included are receipt books, insurance information, tax information, Electric and Telephone company records, and ledger books.
