# **Biographical Note:**

The League of Women Voters of Tullahoma was established in April of 1968. It was one of many local chapters of the state organization, the League of Women Voters in Tennessee, and the national organization, the League of Women Voters of the United States. They met regularly to plan local activism and assist the national organization in their campaigns. The Tullahoma chapter was involved with a variety of local and national issues, including education, the environment, political participation, and taxation. In 1991, the League of Women Voters of Tullahoma changed their name to the League of Women Voters of Highland Rim, which is reflected in the documents in this collection. The Highland Rim chapter went defunct sometime in the 1990s.

# **Scope and Content:**

The collection consists of materials produced and/or used by the League of Women Voters of Tullahoma which met in Tullahoma, Tennessee. The date of the materials in the collection range from 1962-1993. The collection includes administrative records, correspondence between League chapters and individual League members, materials related to local and national events, materials related to the League's policy positions on a number of issues, and local, state, and national League of Women Voters publications. The local records give a sense of the League of Women Voters of Tullahoma's stances on important issues, as well as how their organization functioned, raised money, and advocated for the policies they desired to see enacted.

**Arrangement:** The records were arranged according to original order and functions of the organization. Arranged by series and chronologically within series and sub-series. Series 6 is arranged by subject rather than chronologically.

These materials are arranged into six series: Administrative Files; Candidate and Election Files; Correspondence; Events and Conventions; Publications; Subject Files.

Series 1: Administrative Files, 1966-1993 (19 folders)

This series includes administrative files related to the LWV of Tullahoma, LWV of Tennessee, and LWV of the United States, including annual reports, bylaws, financial records, membership records, minutes, and bylaws.

Series 2: Candidate and Election Files, 1972-1990 (1 folder) This series contains files related to the LWV of Tullahoma's feelings about and questions for political candidates.

# Series 3: Correspondence, 1968-1993 (3 folders)

These files contain correspondence between LWV members, both internal and external. Internal correspondence is defined as correspondence between LWV of Tullahoma and other League chapters, or correspondence between LWV members. External correspondence is defined as correspondence between the League and outside organizations or individuals.

Series 4: Events and Conventions, 1972-1992 (7 folders) This series contains files related to events and conventions organized by and attended by LWV of Tullahoma members.

Series 5: Publications, 1962-1993 (7 folders) These files contain materials published by the LWV of Tullahoma, LWV of Tennessee, and LWV of the United States.

Series 6: Subject Files, 1968-1992 (28 folders) This series contains files related to issues the LWV of Tullahoma sought to educate voters and politicians about, both on the local and national level.
