Pursuant to 34 CFR [§668.43](#), Middle Tennessee State University (MTSU) provides the following disclosure related to the educational requirements for professional licensure and certification necessary for employment in Tennessee.

MTSU’s College of Education educator preparation programs are accredited by the Council for the Accreditation of Educator Preparation (CAEP) and approved by the Tennessee Department of Education. Admission to an educator preparation program does not guarantee that students will obtain a license. Successful completion of one of MTSU’s teacher preparation graduate programs listed below meets the educational requirements for practitioner teacher licensure in the state of Tennessee.

MTSU educator preparation programs lead to licensure in Tennessee. Licensing authorities for each state set and enforce their own requirements and standards, which are subject to change. State requirements may include additional and recurring requirements, such as an application, supervision, examinations, continuing education, fees, fingerprinting, a background check, etc.

The State of Tennessee is a member of the National Association of State Directors of Teacher Education and Certification (NASDTEC). Tennessee teacher and other educator licensure may be eligible for reciprocity in other states. Reciprocity is not an automatic or complete transfer of certification; therefore, MTSU strongly recommends that prospective and current students not located in Tennessee or who plan to seek licensure or certification outside the state of Tennessee consult the [Tennessee Department of Education](#) (TDOE), [NASDTEC](#), and the [US Department of Education](#) for information about additional state requirements and contact the appropriate state licensing agency or board before enrolling in a teacher preparation program.
