Pursuant to 34 CFR §668.43, Middle Tennessee State University (MTSU) provides the following disclosure related to the educational requirements for professional licensure and certification necessary for employment in Tennessee.

The Master of Science in Physician Assistant Studies (MS-PAS) in the College of Behavioral and Health Sciences has been granted Accreditation-Provisional status by the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA). Admission to the MS-PAS does not guarantee that students will pass the Physician Assistant National Certifying Exam (PANCE) or obtain a physician assistant license. The educational requirement to sit for the PANCE is an earned degree from a program accredited by ARC-PA. The educational requirements for licensure as a Physician Assistant (PA) in Tennessee include an earned degree from a program accredited by ARC-PA and a passing score on the PANCE. Successful program completion meets the educational requirements and qualifies students to sit for the PANCE and apply for licensure in Tennessee.

The table on page two of this disclosure indicates the states and territories where MTSU has determined, through reasonable, good faith effort, that the MS-PAS does or does not meet the educational requirements to sit for the PANCE or obtain licensure as a Physician Assistant. Licensing authorities for each state set and enforce their own requirements and standards, which are subject to change. State requirements may include additional and recurring requirements, such as an application, supervision, examinations, continuing education, fees, fingerprinting, a background check, etc. MTSU strongly recommends that prospective and current students not located in Tennessee or who plan to seek licensure or certification outside the state of Tennessee review the state-specific requirements published on the <a href="https://physicianAssistantEDU website">PhysicianAssistantEDU website</a> and contact the appropriate state licensing agency or board before enrolling in the MS-PAS. Students should discuss their plans with an advisor to ensure they have the most up-to-date information and guidance regarding licensure requirements.
