MTSU educator preparation programs lead to licensure in Tennessee. The State of Tennessee is a member of the National Association of State Directors of Teacher Education and Certification (NASDTEC). Tennessee teacher and other educator licensure may be eligible for reciprocity in other states. Reciprocity is not an automatic or complete transfer of certification; therefore, MTSU strongly recommends that prospective and current students not located in Tennessee or who plan to seek licensure or certification outside the state of Tennessee consult the [Tennessee Department of Education](#) (TDOE), [NASDTEC](#), and the [US Department of Education](#) for information about additional state requirements and contact the appropriate state licensing agency or board before enrolling in a teacher preparation program. Students should discuss their plans with an advisor and the MTSU [Office of Educator Preparation and Licensure](#) to ensure they have the most up-to-date information and guidance regarding licensure requirements.
