**Section 1:** Homecoming King and Queen shall serve the student body for five (5) hours per month during their reign.

Attached you will find Senate Resolution 4-08-F. The legislation suggests requirements to increase the participation of those individuals selected as Homecoming King and Queen. I appreciate the Senate's attempt to engage the Homecoming King and Queen with the student body, but I believe the legislation requires additional consideration.

Prior to this office endorsing the legislation, I suggest the following items be clarified:

- 1) identify the period of time that the king and queen "reign";
- 2) identify the process to be used to remove an individual from their position if they fail to meet the specified requirements;
- 3) clarify the individual(s) who will be responsible for monitoring attendance at events
- 4) identify the types of activities that would be considered acceptable to meet the five hour requirement.
