**ASSOCIATION OF MIDDLE TENNESSEE STATE UNIVERSITY THAT:**


**Section 1:** The student activity fee will rise from \$20 to \$40 for everyone who has 7 hours or more.


**Section 2:** The current percentage that is used to distribute between the SGA, Student Organizations, Sports clubs, Student Programming and Distinguished lectures will remain the same.


