CJA 1100 Criminal Justice Administration

Proposed for Explorations in History & Civic Learning
Department represented by Dr. Elizabeth Wright, also an Implementation Team
member

The committee noted that the word "administration" in the course title distracts from general education goals. The department agrees and has plans to remove it in the future. There was some committee discussion about whether the course was too career-oriented; however, the course is not required for majors and the career information is provided for non-majors.

COMM 2140 Introduction to Organizational Communication

Proposed for Explorations in Human Society and Social Relationships Department represented by Mary Beth Asbury, Chair, Communication Studies

The committee expressed concerns about alignment of the course to the critical thinking outcome. They noted that the assessable assignment was mostly about describing observations, not critical analysis and wanted to see a better alignment between the assignment and the outcome.

COMM 2140 TABLED: 14-1-1

COMM 2100 Introduction to Health Communication

Proposed for Explorations in Human Society and Social Relationships Department represented by Mary Beth Asbury, Chair, Communication Studies

The committee raised concerns about the validity of this course for the category and specifically about the alignment of the assessable assignment with the critical thinking outcome.

Committee members asked for clarification on the implications of a motion to table v. rejecting a proposal. Myers-Shirk explained that tabled proposals could be brought back to the committee at any time and that the course originator/department could provide additional information that would allow the committee to reconsider the proposal. Rejecting a proposal sends it back to the course originator and requires them to submit a new proposal.

COMM 2830 Introduction to Online Communication

Proposed for Explorations in Human Society and Social Relationships Department represented by Mary Beth Asbury, Chair, Communication Studies

Some committee members raised concerns about whether the course was appropriate to the category and whether the assessable assignment aligned sufficiently to the critical thinking outcome.

Amy Sayward motioned to table, but was not seconded

COMM 2830 APPROVED: 14-1-1

INFS 1300 Introduction to Cybersecurity

Proposed for Explorations in Human Society and Social Relationships Department represented by Tim Greer, Department Chair, and Nita Brooks

The committee expressed concerns that the title did not reflect general education content of the course. Several committee members made suggestions for alternative titles that would be more appropriate for a general education course.

There was some discussion about how quickly and by what mechanism the title could be changed. Some committee members expressed concern that the current title implied the course was too oriented toward professional skills and preferred to have the title changed in time for the 2024 catalog.

Keith Gamble motioned to approve conditional on a change in title as soon as possible; Suzanne Mangrum seconded.
